of the Supreme Court, the use of cultural norms in criminal and civil cases, and current ethical issues facing counsel in criminal cases. We ended the

afternoon with an informative session entitled, "*Pot or Not?*" which included issues relating to the collision of Guam law with federal law regarding the legalization of marijuana for medical and recreational use. Panel members included Dr. Paul Coty, the Chief Medical Officer of Guam Regional Medical City; Attorney General of Guam Elizabeth Barrett-Anderson; Drug Enforcement Agency Resident Agent in Charge Kirk Williamson; Federal Public Defender John Gorman; Presiding Judge Alberto Lamorena, III of the Superior Court of Guam; Mr. Gerard Cruz, President of Community First Guam Federal Credit Union; and attorneys Dana Gutierrez and Jacqueline Terlaje.

## **Online Payment of Fees**

In March 2017, the District Court of Guam began to accept Visa, MasterCard, American Express, and Discover credit card payments online for filing fees associated with bankruptcy cases and the opening of



civil actions. Automated Clearing House payments from checking accounts are also accepted.

## Handbook for Pro Se Litigants

In February 2017, the Clerk's Office released a new, locally developed publication for self-represented litigants entitled *"Filing a Civil Case on Your* 

*Own Behalf*<sup>°</sup>. This 20-page document describes the filing and procedures associated with civil actions in a way that is easy to understand. It may be found on the court's website or may be obtained over the counter.

#### Upgrade of Courtroom Technology

The court has procured the service of an audio/video design engineer to plan a major upgrade of the audio and video technology in its main fourth floor courtroom. The design is nearly complete, and the court intends to solicit bids for the installation work in late June 2017. Planned enhancements include widescreen monitors throughout the courtroom, a new audio system, and a new digital video system for evidence presentation. The court hopes to have the installation complete by the end of the calendar year.

#### **Bankruptcy Seminar**

On August 30, 2016, the court hosted a three-hour bankruptcy seminar for members of the Guam Bar Association with Region 15 Acting U.S. Trustee Tiffany Carroll and Assistant U.S. Trustee Curtis B. Ching. Topics included "Information Gathering in Bankruptcy," "Sanctions in Bankruptcy," and "Small Business and Individual Chapter 11 Cases." Members of the bar earned up to three hours of Continuing Legal Education (CLE) for participating in the event.

# Administrative Initiatives

# **Centralization of CM/ECF Servers**

The court moved its electronic filing servers from its computer room in Guam to an installation in the continental United States in March 2017. Electronic filers should perceive an increase in speed and performance when filing documents electronically.

# **Judiciary Integrated Financial** Management System (JIFMS)

The court migrated to an upgraded cloud-based Financial Management System in March 2017. JIFMS interfaces with U.S. Treasury systems and other Judiciary operational systems which will eliminate duplicative entry and strengthen internal controls.

# Upgrade of Court Website

In November 2016, the court upgraded its website. New features include:

- A feature slider (slideshow) that highlights content important to the public and bar.
- Responsivity for mobile devices, e.g. looks good on smartphones and tablets.
- A revised and streamlined menu system.
- Enhanced search capabilities.

## 14th Amendment Panel Discussion

The court hosted a "Conversatorio" or panel discussion on the 14th Amendment at the courthouse on May 11, 2017. The theme of this event and of Law Week as well, was "The Haggan Games," and a Law Week Fourteenth Amendment: Transforming American Democracy."

The panel, moderated by Attorney Minakshi Hemlani, consisted of attorney and former Guam Senator Robert Klitzkie, Attorney Ignacio Aguigui, and former Congressman and current President of the University of Guam, Dr. Robert Underwood.

The invited audience was comprised of students from the University of Guam, Guam Community College, and members of the Guam Youth Congress. The discussion centered on the history of the 14th Amendment and its clauses, especially the Citizenship, Due Process and Equal Protection clauses. The panelists also provided their perspectives on the applicability of this constitutional amendment to Guam.
