Kaleb Udui, Jr. Minister of Finance, Republic of Palau

Kaleb Udui, Jr. is the Minister of Finance for the Republic of Palau, having been sworn into office on February 8, 2021. His public service began as the Chief of the Division of Budget and Management three decades ago. He later served as the Financial Advisor to the Ministry and Manager for an UNDP project that covered Personnel, Tax, and Planning reforms. In the 2000's, Minister Udui worked in banking and also served as the President of the National Development Bank of Palau. His private business activities have been in banking, energy consulting and in real estate. He has also served on various public and private boards including Palau's Banking Supervisory Board and the Palau Chamber of Commerce.

Minister Udui is a Palau Government delegate to the Economic Advisory Group (EAG). He has a Bachelor's degree in Finance and Economics from the University of Guam and a Masters of Business Administration from the University of Hawaii.



Chantale Wong United States Executive Director, Asian Development Bank

Ms. Chantale Wong was nominated by President Joe Biden to serve as the U.S. Executive Director for the Asian Development Bank with the designate of Ambassador. She was confirmed by the Senate on February 8, 2022 on a bipartisan vote and was sworn in by Secretary of Treasury Janet Yellen on February 23, 2022 as the first openly LGBTQ+ person of color Ambassador in U.S. history.

Prior to her retirement from Federal service in 2014, she was appointed by President Barack Obama to serve as Vice President for Administration and Finance, and Chief Financial Officer at the Millennium Challenge Corporation ("MCC"). Prior to her work at MCC, she was the budget director at the National Aeronautics and Space Administration during the retirement of the space shuttle, the acting budget director at the U.S. Department of the Treasury during the 2008-2009 financial meltdown, and the Chief of Staff to the Director of the Office of Management and Budget (OMB). Ambassador Wong was appointed by President Bill Clinton to represent the United States on the board of directors of the Asian Development Bank as the Alternate U.S. Executive Director and was also acting as the U.S. Executive Director in 1999-2002.

Ambassador Wong was born in Shanghai and migrated to Hong Kong as a young girl. After moving to Guam with her aunt and uncle, she attended the Academy of Our Lady of Guam, where she graduated in 1976, the same year Chief Judge Tydingco-Gatewood graduated from George Washington High School. Ambassador Wong and Chief Judge Tydingco-Gatewood were both student body presidents of their high school and worked closely together on leadership activities at their school.

Ambassador Wong holds a Master in Public Administration from the Kennedy School of Government at Harvard, where she was a Littauer Fellow and a Women's Leadership Fellow. She has another Master in Environmental Engineering from the University of California, Berkeley, with a focus on water and wastewater management. She earned her undergraduate degree in civil and structural engineering from the University of Hawaii.

Hon. M. Margaret McKeown United States Circuit Judge, United States Court of Appeals for the Ninth Circuit

Judge McKeown was appointed to the U.S. Court of Appeals for the Ninth Circuit in 1998 by President Bill Clinton. Judge McKeown was the first female partner with the law firm of Perkins Coie in Seattle, Washington, and in Washington, D.C.

Judge McKeown is a frequent speaker on judicial ethics, having served for more than a decade on the Judicial Conference of the U.S. Codes of Conduct Committee, the ethics committee for the federal judiciary, including as the committee's chair. She has also lectured and taught extensively on judicial administration, international law, litigation, constitutional law, and intellectual property in Latin America, Asia, and Europe. She is co-author of Trial Tactics in Trade Secret Litigation, Intellectual Property Counseling and Litigation (Matthew Bender), Citizen Justice: The Environmental Legacy of William O. Douglas-Public Advocate and Conservation Champion (Potomac Books), and a number of other books.

Judge McKeown has been recognized for her outstanding work. She received the American Bar Association's Margaret Brent Women Lawyers of Achievement Award, the Federal Bar Association's Community Service Award, and the Girl Scouts' Cool Women Award. She received her Bachelor of Arts degree from the University of Wyoming in 1972, graduating Phi Beta Kappa, and her Juris Doctor from Georgetown University Law Center in 1975.



Hon. Richard R. Clifton United States Circuit Judge, United States Court of Appeals for the Ninth Circuit

Judge Clifton has been a judge of the U.S. Court of Appeals for the Ninth Circuit since 2002. His chambers are in Honolulu, Hawaii. After graduating from Princeton University (A.B. 1972) and Yale Law School (J.D. 1975), he moved to Hawaii to serve as a law clerk for Judge Herbert Y.C. Choy, the first Hawaii resident to serve on the Ninth Circuit and the first Article III federal judge of Asian ancestry. Judge Clifton practiced law in Honolulu for 25 years until his appointment to the court. He was a member of the Judicial Conference Committee on Federal-State Jurisdiction for ten years (2009-19), the last four years of that term as its chair. In that capacity, he was a liaison between federal and state courts and regularly attended meetings of the Conference of Chief Justices. He is a director of the American Judicature Society, the Ninth Judicial Circuit Historical Society, the Hawaii Women's Legal Foundation, and a member of the American Law Institute, the Ninth Circuit Pacific Islands Committee, and the Pacific Judicial Conference.

For 24 years he was a director of Hawaii Public Radio, six years as its chair. He has taught as an adjunct professor at the University of Hawaii Richardson School of Law intermittently since 1979 and has participated in programs as jurist in residence at several law schools. He is married to Terry Clifton, has two adult children, and is a devoted fan of the Chicago Cubs. He assumed senior status on December 31, 2016, and continues to hear cases in that capacity.

Hon, Daniel P. Collins United States Bankruptcy Judge, District of Arizona

U.S. Bankruptcy Judge Daniel P. Collins was appointed a Judge of the U.S. Bankruptcy Court for the District of Arizona, effective as of January 18, 2013. He served as the Chief Bankruptcy Judge for the District of Arizona from March 2014 to March 2018. Prior to taking the bench, he was a shareholder of the law firm of Collins, May, Potenza, Baran & Gillespie, P.C., located in Phoenix, Arizona. He received a Bachelor of Science degree in finance and accounting (1980) and J.D. (1983) from the University of Arizona.

Judge Collins is presently on the 9th Circuit's Bankruptcy Education Committee, is the Education Chair for the National Conference of Bankruptcy Judges, will be NCBJ's President in 2022-3, is a member of the Board of Directors of the American Bankruptcy Institute, is on ABI's Education Committee and Diversity Committee, is on the Board of the Phoenix Chapter of the Federal Bar Association, is a Fellow of the American College of Bankruptcy and is a member of the University of Arizona Law School's Board of Visitors. He is a founding member of the Arizona Bankruptcy American Inn of Court. Dan and his wife Roseanne raised their 5 children in Phoenix, Arizona.



Rear Admiral Benjamin Nicholson

U.S. Naval Forces, Marianas/Commander, Joint Region Marianas

Rear Admiral Benjamin Nicholson assumed command of Joint Region Marianas in 2021. His previous sea duty assignments include commander and deputy commander, Destroyer Squadron 22, embarked on USS George H. W. Bush (CVN 77); commanding officer and executive officer of USS Pinckney (DDG 91); commanding officer of USS Sentry (MCM 3), USS Gladiator (MCM 11), and USS Defender (MCM 2) as part of MCM Crew Swerve; chief engineer on USS O'Bannon (DD 987) and USS McFaul (DDG 74); and division officer on USS Mitscher (DDG 57).

During his seagoing career, he has made numerous deployments around the world from the Western Pacific, Atlantic, and Indian Oceans to the Mediterranean, Caribbean, Adriatic, Red, and North Seas as well as combat operations in the Arabian Gulf and Gulf of Oman; and counter-narcotics operations around South America. He has been fortunate to have served with multiple Battle Effectiveness Award (Battle "E") winning crews.

His military decorations include the Defense Superior Service Medal, Legion of Merit, Bronze Star, Defense Meritorious Service Medal, Meritorious Service Medal (three awards), Navy Commendation Medal (four awards), Joint Service Achievement Medal, Navy Achievement Medal (three awards), Combat Action Ribbon, and various campaign and unit awards. He is also a 2015 recipient of the FBI Director's Award.

Rear Admiral Nicholson is a 1993 graduate of the U.S. Merchant Marine Academy with a Bachelor of Science in Marine Engineering. He also earned a Master's degree in Systems Engineering from the Naval Postgraduate School and a Master's degree in National Security from the Naval War College.

Office of the Clerk of Court

The last two years have been quite challenging for the court, as they have been for the entire island. Here are some noteworthy projects undertaken by the Clerk's Office during the pandemic to date.

Hybrid Virtual/In-Person Hearings

The court, with the help of its Information Technology staff, implemented a hybrid virtual/inperson courtroom configuration that complies with the "Coronavirus Aid, Relief, and Economic Security Act" (CARES Act) and the policy of the Judicial Conference of the United States (JCUS). The video conferencing systems connect directly to Zoom™ for case participants, and a parallel ZoomTM conference allows media outlets and the public to view and listen to court hearings.

The CARES Act authorizes the use of video and telephone conferencing, under certain circumstances and with the consent of the defendant after consultation with counsel, for various criminal proceedings, during the course of the Coronavirus pandemic emergency, contingent upon a finding by the Judicial Conference of the United States (JCUS) that emergency conditions exist that materially affect either the federal courts generally or a particular district court of the United States. The JCUS made such a finding, and on March 29, 2020, the Executive Committee of the JCUS, acting on an expedited basis on behalf of the Conference, approved a temporary exception to the Conference broadcast and cameras policy to allow a judge to authorize the use of teleconferencing to provide the public and media audio access to court proceedings. This authorization will expire when the Judicial Conference finds that emergency conditions are no longer materially affecting the functioning of federal courts. Traditional forms of "broadcasting" court proceedings, such as livestreaming court hearings on the internet, are still prohibited by Rule 53 of the Federal Rules of Criminal Procedure.

Pandemic Recovery

The court conducted five jury trials, two of which utilized 18 jurors, during the pandemic thus far. The trials required changes to the courtroom configuration and jury deliberation room in order to facilitate compliance with social distancing protocols due to the pandemic.

General Order 22-0012, issued on May 6, 2022, rescinded the mandatory use of facemasks in the U.S. courthouse, and General Order 22-0014, issued on May 26, 2022, rescinded the court's social distancing protocols.

New Criminal Justice Act Plan

The Court of Appeals for the Ninth Circuit approved an amended Criminal Justice Act (CJA) Plan for the District of Guam on November 18, 2021. The CJA, 18 U.S.C. § 3006A, secures the Sixth Amendment right to counsel for federal criminal defendants. Enacted in 1964, the CJA provides a system for appointing and compensating lawyers to represent defendants financially unable to retain counsel as well as providing for payment of experts, investigators, or other needed defense services in federal criminal proceedings. The new plan implements the interim recommendations of a national CJA review committee with respect to the selection, appointment, retention, and removal of CJA panel attorneys. In addition, the new plan provides for review of vouchers submitted by panel attorneys by a supervising attorney not employed by the District Court of Guam.

Members of the bar with substantial experience in felony defense are encouraged to apply for membership to the panel.

Online Payment of Fees

Effective May 2022, the Clerk's office accepts ACH, PayPal and Debit card transactions for court ordered payments in criminal cases and miscellaneous court fees. Third party payments are also now accepted. The online form may be

New Telephone System

The court is implementing a new voice-over-IP (VoIP) telephone system which will connect it seamlessly to the U.S. Courts National IP Telephone System. The new system will allow for greater flexibility, especially for teleworking staff members and have a substantially annual reduced cost. The project should be completed by the end of 2022.

Magistrate Courtroom Upgrade

The court is pursuing a project to overhaul the audio and video systems in its Magistrate Courtroom. The current system was implemented in 2007 and while it is still functioning, it is overdue for an upgrade. The new system will include new video conferencing system, larger digital monitors, and new pan-tiltzoom cameras. The system architecture will deploy HDBaseT technology and will be nearly entirely High-bandwidth Digital Content Protection (HDCP) compliant. HDBaseT is the global standard for the transmission of ultra-highdefinition video, audio, Ethernet, USB and up to 100W of power over a single, long-distance, cable. The project should be complete by the end of the first quarter of 2023.


Other Matters


Effective June 15, 2022, the Court approved the use of associate attorneys for tasks in which lead court-

appointed attorney expertise is not required and where the total fees for court-appointed counsel do not exceed the statutory maximum. The associate attorney is now permitted to bill at the rate of \$85.00 per hour.

Civil Cases Filed by Nature of Suit


12 months ending June 30, 2022






Criminal Offense Filings by Case Type

12 months ending June 30




Magistrate Felony Proceedings

12 months ending June 30






Gregory Arriola Special Offender Specialist

In October 2021, Probation Officer Gregory Arriola in the NMI office was promoted to Special Offender Specialist. Officer Arriola began his career at U.S. Probation in August of 2010. Since then, he has had to learn everything "probation" because of the small size of the office. To that end, he has mastered location monitoring, is a District Firearms Instructor and Officer Safety Instructor. He is also certified in search and

seizure and is learning the complexities of cybercrime including monitoring computers, multimedia, and data storage devices. Officer Arriola is an exceptional officer, and his positive contributions are felt on a daily basis.

Training

On July 28, 2021 the Districts sponsored a virtual Bureau of Prisons (BOP) Symposium which was facilitated by BOP staff from across the nation. There were many participants in both the Districts of the NMI and Guam, including the U.S. Attorney's Office, the Federal Public Defender, and the Criminal Justice Act (CJA) Panel. Some of the speakers from the BOP spoke on behalf of their respected professions from MCC San Diego; FCC Victorville; FCC Tucson; FCl Safford: and USP Leavenworth. There were presentations about designation processing for inmates; inmate medical and mental health classifications; sex offender treatment programs; residential drug abuse programs; education and vocational training; and COVID related strategies. This valuable information was made available to the participants and it also provided a venue to ask follow-up questions on pressing issues regarding inmate welfare.



Both district offices have continued to make inroads in the use of technology and meeting the challenges of working dynamically during a pandemic. By utilizing Microsoft Teams and Zoom, staff have been able to keep in touch with each other and attend court hearings and trainings. Some of the practices employed during the pandemic are here to stay. Officers will continue to make use of virtual contacts (Facetime, WhatsApp) with clients. There are so many benefits to this kind of contact. Officers are able to have greater access to their clients. For example, they can participate in treatment sessions, make contact during non-business hours, and conduct home. employment, and collateral visits. Teleworking has been a real boost to ongoing operations. Staff having to isolate or quarantine because of





Events





Office of the United States Attorney

The United States Attorney's Office (USAO) conducted jury trials during the COVID-19 pandemic period. These criminal trials involved defendants convicted by jury of drug trafficking, attempted child enticement, and wire fraud, money laundering, theft of government property, and conspiracy offenses.

The prosecution of drug crimes comprised 38% of the USAO's caseload. Other cases consisted of violent crimes, white collar crimes, government regulatory offenses, immigration, and official corruption. United States v. Pacific International Lines (Private) Limited (PIL) et al., was an example of a government regulatory offense prosecution with the Department of Justice (DOJ) Environmental Crimes Section. A Singaporean company and its engineers were convicted of felonies for failing to accurately maintain their oil record book, and knowingly discharging oily bilge water in Apra Harbor, and paid a criminal penalty of \$3 million.

The USAO and Guam Attorney General held trainings on search and seizure, and federal firearms offenses for law enforcement. The USAO also hosted an Unmanned Aircraft Training for law enforcement with speakers from DOJ's National Security and Cyber Crime Section, the FAA, and DOD. The USAO held community outreaches including Elder Justice Initiative training, and, with DEA, the Prescription Drug Take Back Initiative and Red Ribbon Campaign to promote a drug-free Guam. The USAO and ATF held law enforcement trainings about identifying "Ghost Guns."

The USAO Civil Division's caseload included admiralty, asset forfeiture, bankruptcy, civil rights, commercial litigation, environmental, land, fraud, immigration, prisoner litigation, program litigation, social security, and torts. The division's Financial Litigation Program recovered \$2,109,345 in criminal restitution and \$418,000 in civil judgments and the Asset Forfeiture Unit seized substantial properties and

The Civil Division pursued legal actions in areas including: its

DEA Diversion cases to protect both Guam and the NMI from opioid and other prescription drug abuses; seeking justice for Government of Guam retirement benefits when employees are deployed for military service; assuring the delivery of safe drinking water to residents and enforcing sewage treatment; collecting restitution for victims; and pursuing actions to force compliance with national standards. The division also represented and defended federal agencies and their agents and employees.

Office of the Federal Public Defender

The Office of the Federal Public Defender (FPD) has weathered the COVID-19 storm and looks forward with renewed optimism. Despite the travails of the pandemic, Guam's Federal Public Defenders continue to be motivated by a simple belief - that justice should not depend on the color of your skin or the size of your wallet.

Our office, which has been open for 28 years on Guam, is small but formidable. We have three attorneys, Leilani Lujan, Briana Kottke and the Federal Public Defender, John T. Gorman. We are bolstered by Administrative Officer, Lita McDaniel, Administrative Assistant, Renate Grimes and Chris Mantanona, our Computer System Administrator. Our caseload consists of major drug trafficking cases, firearms, immigration, fraud and theft offenses and other federal crimes. We provide zealous, effective representation for indigent clients charged with criminal offenses in

federal court.

We adjusted our workplace and initiated strict protocols for our office in response to the pandemic to protect our clients and our staff. We successfully balanced face to face client meetings with interactive video conferencing for client interviews and court hearings. Overall, we succeeded in keeping our clients and ourselves healthy and continuing our zealous defense. We have also embraced telework and have incorporated it fully in our workplace.

One of our major pandemic office initiatives was obtaining the release of federal inmates through the compassionate release program. Prison facilities are overcrowded, old and poorly ventilated, with tight quarters and terrible hygiene conditions. Uneven testing, inadequate medical resources and the constant churn of staff members, visitors and inmates made the system a perfect breeding ground for the

virus. Our office, along with our national partners, filed a number of motions for compassionate release to free our clients who were particularly at risk due to various comorbidities. We filed 14 compassionate release motions and while several are pending, we are happy to report that seven clients were freed to timeserved or house arrest.

Our office is also

extraordinarily proud of our nation's newest Supreme Court Justice, Ketanji Brown Jackson. She is, of course, the first Federal Public Defender to ascend to the Supreme Court. While there have been an abundance of former prosecutors and well heeled civil attorneys on the Court, there has never been a public defender nor has there been a criminal defense lawyer in decades. Ms. Brown Jackson's elevation demonstrates an acknowledgment that public defenders have a deep commitment to individual liberty, to the ideals that the legal system must safeguard all Americans, not just the wealthy and powerful, against governmental overreach. We are also heartened that President Biden, perhaps owing to his own public defender experience, has appointed a

record number of public defenders to federal judgeships.

Our office will also be seeking new leadership in the upcoming year. FPD John T. Gorman, will not be seeking reappointment from the Ninth Circuit Court of Appeals. His term ends on November 16, 2023. Due to the strength of the office, we do not anticipate any problems as we transition to the next FPD.

Our office will continue to speak for the silenced and everyone who has felt powerless or dehumanized when they step into a courtroom. We remain committed to the guarantees of the presumption of innocence and every individual's right

to equal protection under the law.

United States Marshals Service

The USMS is responsible for ensuring the safety of the Federal Judiciary and other court officers: maintaining order during court proceedings; maintaining the security of deliberating and sequestered juries; investigating violations of Federal law, apprehending Federal, State, and international fugitives; maintaining the security of witnesses and their families; guarding and transporting federal prisoners; operating the Asset Forfeiture program; serving and executing civil and criminal process; and responding to emergency situations such as civil disturbances, terrorist incidents, hostage situations, natural disasters where there is a violation of Federal law or Federal property is endangered. The USMS is also responsible for the extradition of fugitives apprehended in foreign countries and wanted for prosecution in the United States.

To accomplish its various missions, the agency ensures its workforce is responsive to new and existing challenges. In 2021, the U.S. Marshals Service personnel for the Districts of Guam and CNMI endured an incredibly challenging year to say the least. The COVID 19 pandemic was rampant throughout the island,

resulting in an island-wide lockdown which affected everyone including the Federal Judiciary. Although the lockdown was in full effect, the USMS adapted- with key personnel continuing to diligently perform their respective duties and thus accomplished their mission.


The following are the accomplishments and other initiatives undertaken by USMS in the past year:

- The District of Guam successfully executed its mandated mission in all mission areas for FY 2022. Notable Achievements:
- Executed 14 JPATS prisoner missions transferring 30 federal prisoners to their designated Bureau of Prison facilities safely and without incident to date.
- Executed 5 multi-agency Sex Offender Compliance operations resulting in the verification of 123 registered sex offenders, 10 noncompliance investigations for "failure to register"; referred to the United States Attorney's Office for prosecution, 2 arrests.
- Conducted over 106 domestic fugitive warrant investigations involving federal, state, and local fugitive warrants resulting in the

- arrest of 81 fugitives. Strengthened International Fugitive Investigation cooperative efforts with law enforcement counterparts from Laos. Philippines, South Korea, Thailand, and Vietnam through Asia Pacific Liaison (APIL) outreach that resulted in the investigation of 150 international fugitive cases and subsequent closure of 50 cases.
- Managed approximately 2.5 million dollars in seized asset forfeiture property and monies from federal criminal investigations.
- District onboarded two new personnel. A Supervisory Deputy United States Marshal and a Judicial Security Inspector.

As members of the Board of Governors may change, the new office fosters a seamless transition between administration. The GBA is proud to announce the American Bar Association's recent adoption of Resolution 404, sponsored by the New York and Virgin Islands Bar Associations, to fully support the overruling of the United States

Supreme Court's decisions in the Insular Cases and to urge Congress to enact laws that provide residents of the U.S. territories the same rights, liberties, and protection as citizens of the 50 states. Lastly, the GBA extends our Un Dångkulu na si Yu'us ma'åse' and appreciation to the District Court of Guam, the Judiciary of Guam and the Pacific Judicial Council for providing learning opportunities while receiving CLE credits through the joint conferences.

As the designated representative for the Lawyers' Representative Coordinating Committee (LRCC) for the District of Guam, I work closely with our other representatives within the Ninth Circuit to assist in the planning and coordination of presentations for the Chief Judges Conference, the Annual Ninth Circuit Conference, and our Annual District Court of Guam Conferences held every year. For the past two (2) years, since March of 2020, much of the meetings and presentations have been conducted via and presentation of the 2022 Chief Zoom. The Annual Ninth Circuit Conference for 2020 and 2021 were cancelled due to the COVID-19 pandemic. I am pleased to report that all in person meetings and conferences have resumed starting with the 2022 Chief Judges

2022 Cristobal C. Dueñas Excellence Award

The 2022 Cristobal C. Dueñas Excellence Award has been bestowed upon Federal Public Defender John T. Gorman.

The Office of the Federal Public Defender in Guam celebrates its 28th anniversary this year and Mr. Gorman led the office for the last nineteen years. First appointed to the office Federal Public Defender in 2003 by the U.S. Court of Appeals for the Ninth Circuit, Mr. Gorman is supported by two assistant federal public defenders and three office staff. His office in Mongmong handles approximately 70% of the criminal cases filed in the District Court of Guam. Major drug trafficking cases, firearms, immigration fraud and theft offenses and other federal crimes make up their caseload.

Originally from New York State, Mr. Gorman received his bachelor's degree from Drake University in Iowa in 1980. He served in the Peace Corps in the Bengut province in the Philippines, where he supervised construction of a drinking water system for a tribal group in North Luzon's Cordillera Mountains. From 1985

to 1989, Mr. Gorman was a case worker at refugee camp. He then entered law school at Northeastern University in Boston and received his juris doctor in 1992. While in law school, he clerked for Judge Wendie Gershengorn of the Massachusetts Superior Court. Following law school, he served as a trial attorney with the Defender Association in Philadelphia. In 1997, he relocated to Guam to work as a senior litigator in the Office of the Federal Public Defender.

Mr. Gorman has been a longtime volunteer at Habitat for Humanity on Guam, and was that organization's president for two years. Habitat for Humanity has built dozens of houses for Guam residents since the island chapter was founded in 1996.

"Guam has been blessed to have had John Gorman at the helm of the Office of Federal Public Defender for almost two decades. During that time John has been untiring in his defense of men and women in great need of counsel and advocacy," said Chief Judge Frances Tydingco-Gatewood.

Cristobal C. Dueñas, a graduate of the University of Michigan Law School, was appointed by President Richard M. Nixon on September 23, 1969 to be the first Chamorro judge for the District Court of Guam. On December 10, 1969, he was confirmed by the U.S. Senate and commissioned the next day. By December 24, 1969, he was officially sworn in as the Judge of the District Court of Guam. In June of 1977, Judge Dueñas was reappointed for a second term, and he retired as a Senior Judge in 1991. After a long and distinguished judicial career, Judge Dueñas died on February 14, 2010. He will long be remembered for his humility, courage, and keen intellect.
