We would like to give a warm Hafa Adai welcome to our Guests of Honor: Senior Circuit Judge M. Margaret McKeown, Senior Circuit Judge Richard Clifton, Dean Camille A. Nelson, Director Kari M. Richardson School of Law, will join us at lunch for an introduction to their pipeline project with the University of Guam and the District Court of Guam.

Senior Circuit Judge Clifton and Attorney Anita Arriola will present on the operations of the U.S. Court of Appeals for the Ninth Circuit, elaborating on panel assignments, law clerks, mediation at the appeals level, staff attorney motions, court appointments for indigent defendants, and how judges confer regarding writing assignments and deliberations. John Marshall Law School Professor Kathleen M. Burch will present a Supreme Court Review with a focus on civil cases. Circuit Information Technology Security Officer Reggie Galjour and Cybersecurity Specialist Jake McCloud will discuss how to protect judges and lawyer networks from phishing and social engineering cyber attacks.

On Tuesday, the Pacific Judicial Council Biennial Conference will include presentations and panel discussions on Microsoft 365 and Copilot, Administrative Law, Supreme Court Review with a focus on criminal cases, a judicial perspective on effective appellate advocacy and the art of rebuttal, and understanding the military buildup and its regional impact.

### **Hon. M. Margaret McKeown**

Senior United States Circuit Judge, United States Court of Appeals for the Ninth Circuit

Senior Judge McKeown was appointed to the U.S. Court of Appeals for the Ninth Circuit in 1998 by President Bill Clinton. She was the first female partner with the law firm of Perkins Coie in Seattle, Washington, and in Washington, D.C.

Judge McKeown is a frequent speaker on judicial ethics, having served for more than a decade on the Judicial Conference of the U.S. Codes of Conduct Committee, the ethics committee for the federal judiciary, including as the committee's chair. She has also lectured and taught extensively on judicial administration, international law, litigation, constitutional law, and intellectual property in Latin America, Asia, and Europe. She is co-author of *Trial Tactics in Trade Secret Litigation*, *Intellectual Property Counseling and Litigation* (Matthew Bender), *Citizen Justice: The Environmental Legacy of William O. Douglas—Public Advocate and Conservation Champion* (Potomac Books), and a number of other books.

Senior Judge McKeown holds a Bachelor of Arts degree from the University of Wyoming, and a Juris Doctor from Georgetown University Law Center.



### **Hon. Richard R. Clifton**

Senior United States Circuit Judge, United States Court of Appeals for the Ninth Circuit

Senior Judge Clifton has been a judge of the U.S. Court of Appeals for the Ninth Circuit since 2002. His chambers are in Honolulu, Hawaii. After graduating from Princeton University (A.B. 1972) and Yale Law School (J.D. 1975), he moved to Hawaii to serve as a law clerk for Judge Herbert Y.C. Choy, the first Hawaii resident to serve on the Ninth Circuit and the first Article III federal judge of Asian ancestry. Judge Clifton practiced law in Honolulu for 25 years until his appointment to the court. He was a member of the Judicial Conference Committee on Federal-State Jurisdiction for ten years (2009-19), the last four years of that term as its chair. In that capacity, he was a liaison between federal and state courts and regularly attended meetings of the Conference of Chief Justices. He is a director of the American Judicature Society, the Ninth Judicial Circuit Historical Society, the Hawaii Women's Legal Foundation, and a member of the American Law Institute, the Ninth Circuit Pacific Islands Committee, and the Pacific Judicial Conference.



### **Camille A. Nelson**

Dean and Professor of Law, University of Hawai'i at Mānoa William S. Richardson School of Law

Prior to Dean Camille Nelson's appointment as Dean of the University of Hawai'i at Mānoa, William S. Richardson School of Law in 2020, Dean Nelson served as Dean of American University Washington College of Law ("WCL"), and as Dean of Suffolk University Law School in Boston. She was also a Professor of Law at the Maurice A. Deane School of Law at Hofstra University, a Dean's Scholar in Residence and Visiting Professor of Law at Washington University in St. Louis School of Law, and a Professor of Law at Saint Louis University School of Law, where she was recognized as both Professor of the Year and with a university Faculty Excellence Award. She has taught Contracts, Torts, Criminal Law, Comparative Criminal Law, Transnational Law, Critical Race Theory, Criminal Procedure, and Professional Responsibility at a number of law schools, including the University of Ottawa, Seattle University School of Law, Université Paris Dauphine, and the University of Puerto Rico. She is an elected member of the American Law Institute. Prior to entering academia, Dean Nelson was a litigator at McCarthy Tétrault (a large Canadian law firm), and clerked for Justice Frank Iacobucci of the Supreme Court of Canada, the nation's highest court.

Dean Nelson holds a B.A. with high distinction from the University of Toronto in Administration, a magna cum laude law degree from the University of Ottawa Faculty of Law, and an LL.M. from Columbia Law School.

### **Kathleen M. Burch**

Professor, John Marshall Law School

Professor Burch practiced commercial litigation with Hopkins & Sutter in Chicago for six years before serving as Assistant Attorney General for the State of Yap, Federated States of Micronesia. During her six years in Micronesia, Professor Burch was responsible for providing legal services to various agencies, and advised the Governor on economic development and fisheries issues. As Chief of Litigation, Professor Burch supervised all criminal prosecutions and represented the State in international litigation.

Before joining the John Marshall faculty in 2003, Professor Burch taught at Roger Williams Law School in Rhode Island. Professor Burch has been awarded the ACLU of Georgia's Volunteer Attorney Award. Professor Burch has served on the National Association of Women Lawyers Committee for Evaluation of Supreme Court Nominees. # Office of the Clerk of Court

Despite the great challenges posed by Typhoon Mawar in May 2023, the Office of the Clerk has accomplished quite a bit since the beginning of calendar year 2023. The office implemented projects that improved the administration and operation of the court. The office also wished a fond farewell to a cherished deputy clerk and welcomed two new deputy clerks to the team.

## Typhoon Mawar

Typhoon Mawar passed north of Guam as a Category 4-equivalent typhoon on the evening of May 24, 2023, bringing 140 mile per hour winds and heavy rain making it the strongest storm to affect the island since Typhoon Pongsona in 2002. Up to two feet of rain fell in the northern and central parts of the island. The courthouse suffered significant damage to the air conditioning system on the rooftop which took many months to rectify.

Deputy Clerk Anna Teresa D. Perez joined the Clerk's Office in June 2023 as an Intake Clerk. Anna was formerly an operations officer at a local bank and has a Bachelor of Business Administration degree from the University of Guam.

Deputy Clerk Kasteen B.M. Arceo joined the Clerk's Office in July 2023 as a Case Administrator. Kasteen has over 23 years of experience working in law offices, including serving as Office Manager and legal assistant for a prominent local law firm for 18 years.

## Notable Initiatives

In February 2023 the Clerk's Office implemented GovDelivery, a mass messaging system that facilitates communication with the court's many stakeholders. In the same month, we migrated to a new, more secure website.

An extensive overhaul of the audio and video systems in the Magistrate courtroom was completed in March 2023. This upgrade provides for video to be distributed digitally throughout the courtroom onto larger monitors.

The Clerk's Office began to use the U.S. Judiciary's Judiciary Inventory Control System (JICS) in

April 2023 to manage its personal property. JICS is web-based and is compatible with the Judiciary's financial systems, including being capable of automatically importing applicable purchases and received items. It also has a very flexible reporting feature.

In July 2023, the Clerk's Office implemented a complete replacement of our legacy telephone system which was found to be badly damaged after Typhoon Mawar. The management of civil and criminal debt was also enhanced in July with the adoption of the U.S. Judiciary's Civil/Criminal Accounting Module (CCAM) Intragovernmental Payment and Collections (IPAC) program. Restitution payments to federal agencies are now made electronically instead of by checks.

That same month, the office also began using the U.S. Judiciary's National Fingerprint Transmission System (FTS). FTS is a web-based solution that collects fingerprints and biographic data to support the process of background checks and background investigations. FTS allows the court to take fingerprints of employees, contractors, interns, externs, and volunteers and send them electronically to a central repository at the Administrative Office of the U.S. Courts.

In August, our cashiers began using the U.S. Judiciary's Automated Collections Register (ACR) system. ACR is the U.S. Judiciary's web-based automated collection and receipting system. The application performs point-of-sale receipting for

the courts and can quickly generate receipts from various sources such as walk-in customers, mail-in collections, and wire transfers.

Other notable information technology projects completed include a migration to multi-factor

authentication (MFA) on all of the court's desktops and laptops, and a migration to the U.S. Judiciary's National Active Directory (NAD), nation-wide database and set of services that connect users with the network resources they need to work

efficiently. The benefits of implementing NAD include enhanced enterprise security to court systems, single sign on to countless applications, reduced hardware and administrative costs to the court, and increased network service availability.

## U.S. Probation & Pretrial Services Office

### Staffing

In May 2023, Jeffrey Ventura was promoted to Sentencing Guidelines Specialist. Jeff's journey with the office began as a Probation Clerk in 2009, and then two years later, in 2011, he became a U.S. Probation Officer. As an officer, he began in the supervision unit for a few years but eventually migrated to the investigations unit where his skill sets flourished. He has completed hundreds of presentence investigations since, which is in addition to pretrial investigation reports. He also manages the cybercrime program that was created in 2012 which incorporates digital forensics and

special supervision for clients requiring those conditions. Jeff has a Bachelor's Degree in Historical and Political Studies and a Master's Degree in Criminal Justice Studies.

Trina Duenas was promoted to a U.S. Probation Officer Specialist in May 2023. Trina joined the office in 2014, after working as a Probation Officer in the Superior Court of Guam for eight years. She currently supervises the majority of the defendants on pretrial release. She created and implemented a program to help defendants prepare for

sentencing, imprisonment, and supervision terms. She consistently rates as number one in the country for submitting case plans timely while managing the largest caseload in our District. She oversees the Officer Safety Program which prioritizes officer's awareness, and preparedness for potential threats. She holds a Bachelor's Degree in Psychology and she recently completed the requirements for her Master's Degree in Criminal Justice.

Chantel Maui Royal, a wife, mother of two adorable toddlers, and a full-time college student (Northern Marianas College and the University of Guam), joined the USPO Saipan team in January 2023 as a student intern. Chantel devoted her time

In September 2023, Chantel accompanied the Saipan USPO staff to Guam for the District Court of Guam's retreat and staff development day. ### Training

From December 5 to 6, 2023, the Drug Offender Reentry Program (DORE) Team, consisting of Chief Judge Frances M. Tydingco-Gatewood, U.S. Magistrate Judge Michael J. Bordallo, Federal Public Defender Leilani Lujan, Deputy Chief U.S. Probation Officer Grace D. Flores, Supervisory U.S. Probation Officer John W. San Nicolas II, Valerie Reyes and Portia Dawne Cruz from the Lighthouse Recovery Center, and Lavina Camacho from WestCare Pacific Islands, Inc. attended a two day Federal Judicial Center (FJC) Quality Improvement in Federal Problem Solving Courts Program (QIP) event in San Francisco. They were joined by teams from the Districts of Vermont, Southern Ohio, and Puerto Rico. The first day of training was held at the Northern District of California Courthouse which included a presentation by NDCA re-entry court team, observation of staffing cases with the re-entry team, and attending the re-



entry court session. The second day of training was held at Grand Hyatt and included presentations on QIP, team presentations, a breakout session presentation by role, and expectations for the next 12 months in QIP, which requires monthly web consultations with the FJC.

In June of 2023, the team from the District Court of Guam, consisting of Chief Judge Frances M. Tydingco-Gatewood, U.S. Magistrate Judge Michael J. Bordallo, Chief U.S. Probation Officer Kim R. Walmsley, U.S. Probation Officer Janet Yamashita, and U.S. Probation Officer Specialist Trina Duenas and the team



from the District Court of the Northern Mariana Islands, consisting of Chief Judge Ramona V. Manglona, U.S. Magistrate Judge Heather L. Kennedy, U.S. Probation Officer Specialist Greg Arriola, and U.S. Probation Officer Juanette David-Atalig attended the 2023 FJC-Center for Law, Brain & Behavior *Workshop on Science-Informed Decision-Making*. The

workshop brought together interdisciplinary groups of federal criminal court stakeholders to learn from scholars and clinicians about the process of translating scientific insights into the key criminal case decision points including the initial appearances, violation hearings, presentence investigation, and sentencing.

In August of 2023, the administrative support staff team from the District Court of Guam and District Court of the Northern Mariana Islands attended the 2023 Annual Federal Court Clerks Association (FCCA) Conference that was held in Fort Worth, Texas. The 2023 FCCA Conference was a significant event because it was the first annual conference that was held since the Covid-19 pandemic, and more importantly, it afforded the opportunity for new and existing FCCA members to finally reconnect, network, and promote the exchange of ideas and information in the field of court administration. There were a wide range of presentation topics offered which stemmed from lessons in leadership, building relationships and serving beyond boundaries regardless of job titles, dealing with different generations in the workplace, investing for federal retirement, and Contracting Officers Certification

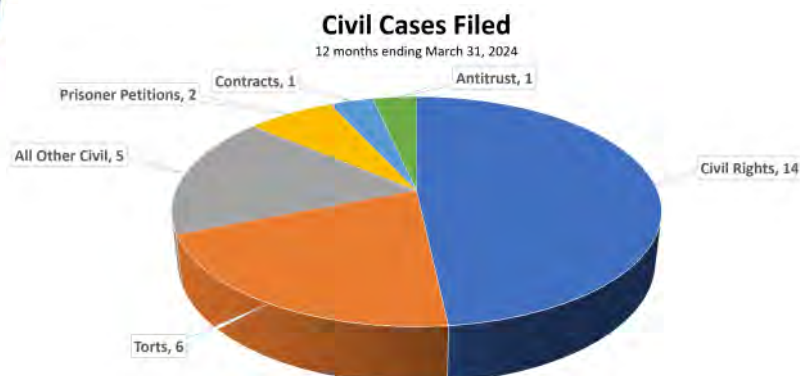
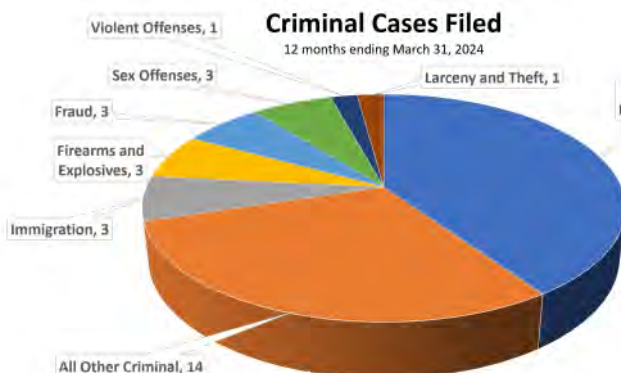
Program Level 3 Training, which was completed by Northern Mariana Islands Administrative Specialist staff.

The first National IT Conference was held in Louisville, Kentucky from August 16-18, 2023. With over 725+ registered attendees from the Circuit offices, District Courts, Bankruptcy Courts, and Probation and Pretrial Offices, there



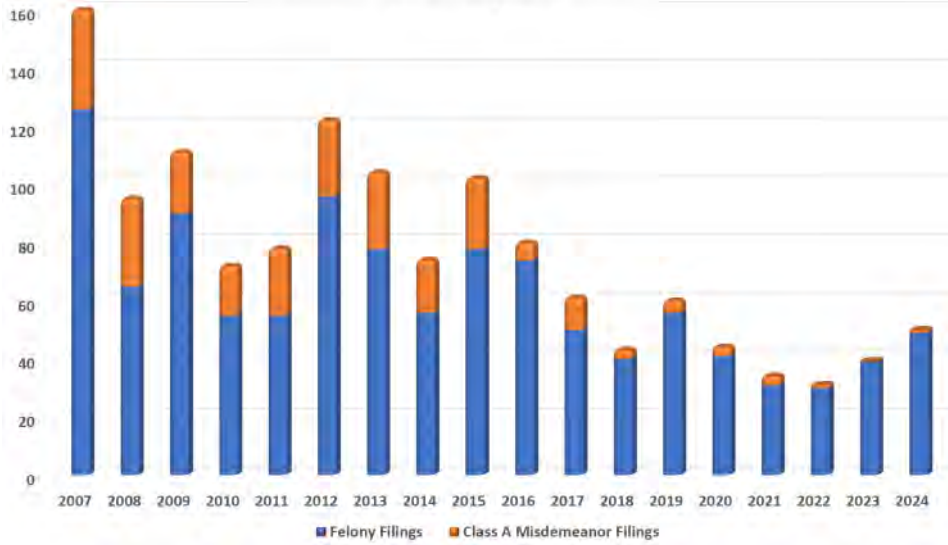

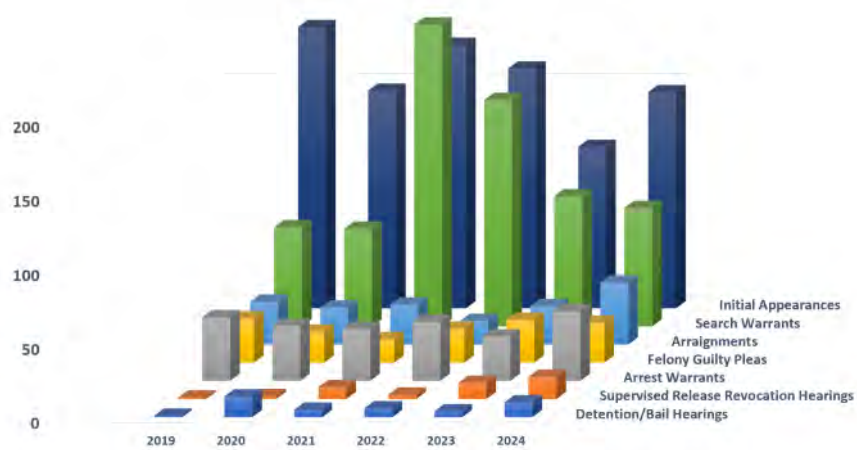
### Criminal Offense Filings by Case Type

12 months ending June 30



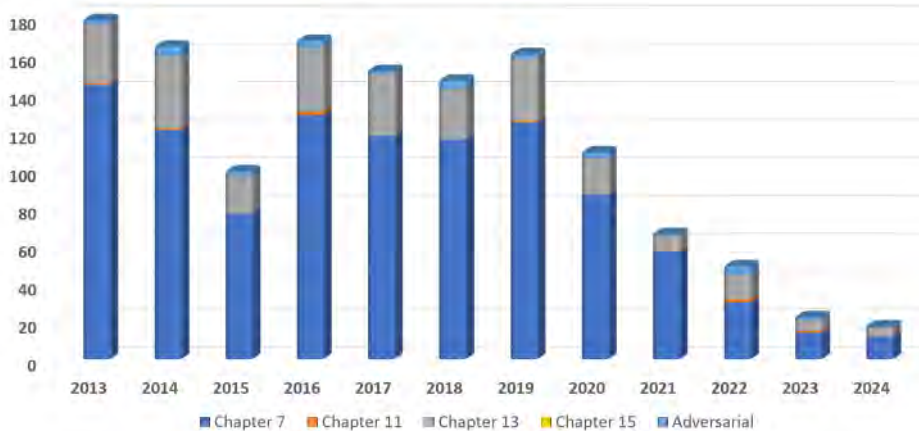
### Magistrate Felony Proceedings

### Bankruptcy Filings

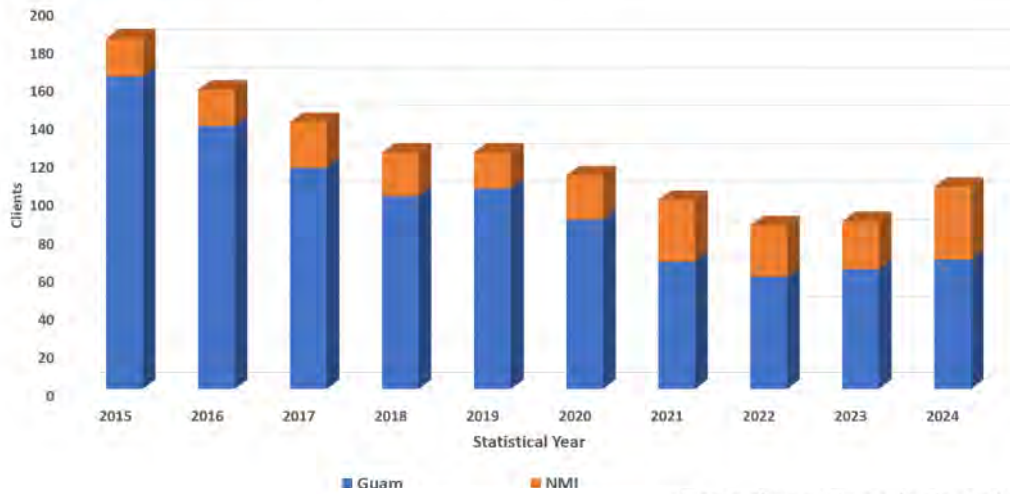
12 Months Ending June 30





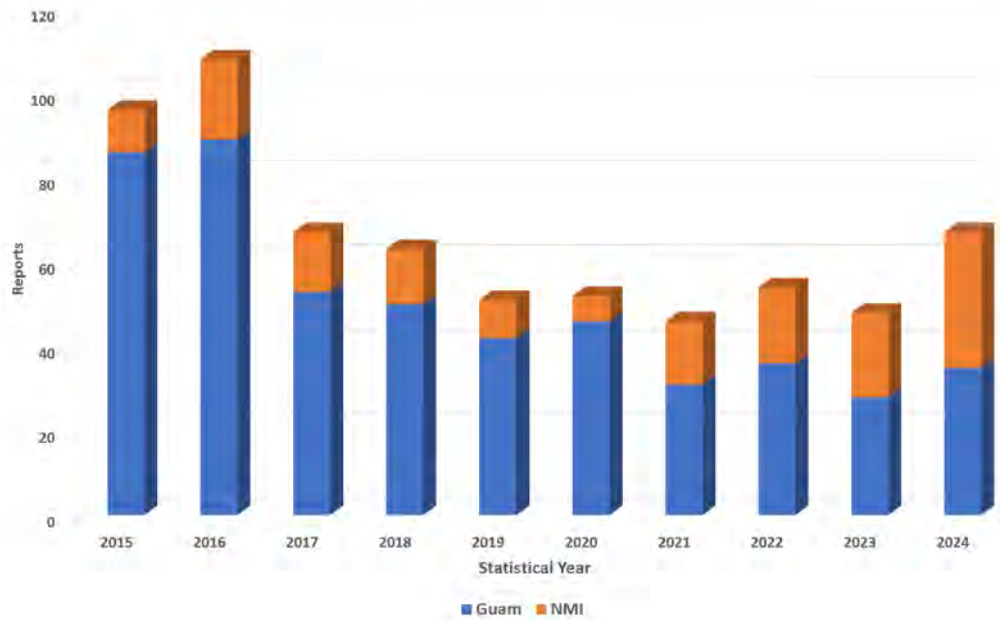
### Pretrial Clients Supervised

12 months ending June 30



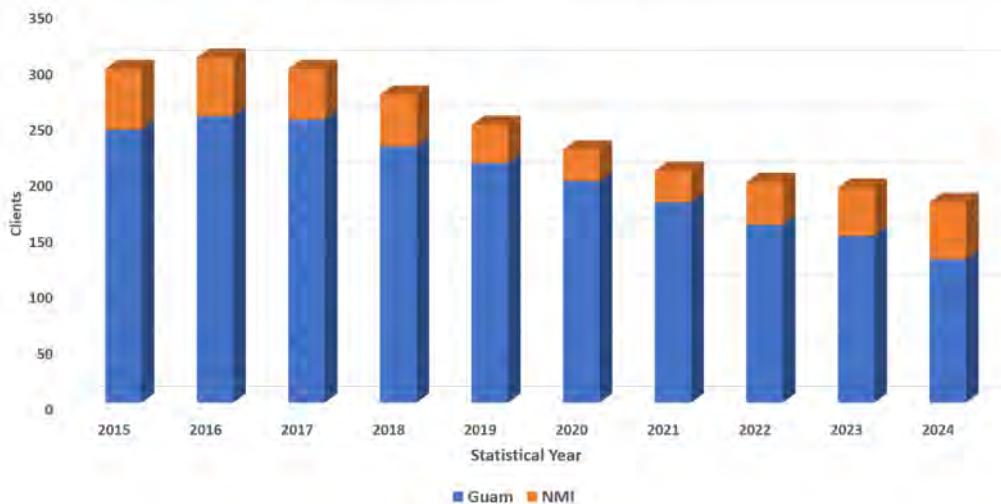
### Presentence Reports Completed

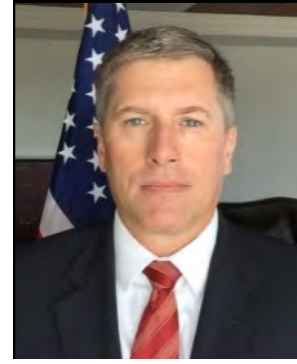
# Office of the United States Attorney

In 2023, the United States Attorney's Office (USAO) Criminal Division prosecuted narcotics, immigration, theft, fraud against businesses, advance fee schemes, violent crimes, and government regulatory offenses - one of which involved the forfeiture of cryptocurrency worth over \$11 million. The USAO pursued several nationwide initiatives, including Project Safe Childhood (PSC) and Project Safe Neighborhoods (PSN), through focused enforcement. PSC's mission is to combat internet or technology-facilitated sexual exploitation of children. The program coordinates the resources of USAOs, federal law enforcement, and the National Center for Missing and Exploited Children. Two notable cases involved defendants convicted of enticement of a minor and possession of child pornography. PSN's mission is to reduce violent crime. Two notable cases involved a former Guam Police officer sentenced to 20 years imprisonment for trafficking methamphetamine and carrying firearms during the commission of the drug trafficking crime. He was also ordered to forfeit \$146,728, 12 firearms, and over 5,900 rounds of ammunition. The other

case involved a drug boss convicted of drug and firearm offenses who was sentenced to 30 years imprisonment, forfeiture of \$219,144, four vehicles, electronics, jewelry, one firearm, and 22 rounds of ammunition.

The Civil Division prosecuted cases involving environmental, employment, medical malpractice, finance, contract fraud, maritime, immigration, and asset forfeiture. The Division handled several whistleblower, Qui Tam actions to detect and prosecute fraud involving federal funds. In one case, the United States allowed a private law firm on Guam to represent the United States at trial involving misrepresentations to the Small Business Administration, resulting in a settlement that returned funds to a U.S. program that benefits minority-owned businesses. Recent on-site visits in long-standing cases included the closed Ordot Dump, the Department of Corrections, and the Chamorro Land Trust offices. Civil Division enforcement activity increased in both districts during this period.

The Asset Forfeiture Unit focused on disrupting criminal activity by seizing and forfeiting

illegal proceeds and tools of the trade. Training was also provided to law enforcement to enhance their work. This included a Financial Investigations Seminar with DOJ's Money Laundering and Asset Recovery Section, which was attended by over 110 federal and local law enforcement agents. The Civil Division also lectured at a symposium in Vietnam on illegal fishing enforcement, by invitation of the State Department and a regional coalition of foreign governments.

The USAO also engaged in community outreach in both districts for PSN, PSC, Elder Justice and Red Ribbon programs.

# Office of the Federal Public Defender

Hafa Adai from the Office of the Federal Public Defender (FPD) for the Districts of Guam and the Northern Mariana Islands! This year, we celebrate our 30<sup>th</sup> anniversary with excitement and optimism. Our office was opened in 1994 as a branch of the Hawaii FPD and became an independent office in 2001. For 30 years, our office has been motivated by the belief that justice should not depend on who you are or the size of your wallet.

2023 was eventful and historic. In May 2023, we survived Typhoon Mawar, which pummeled Guam with winds of over 140 miles per hour. Though Guam was without

water and power for weeks, we resumed operations almost immediately thanks to teleworking and the Judiciary's Safe Haven program. In August 2023, the Ninth Circuit Court of Appeals approved the expansion of our office to include the District of the Northern Mariana Islands. In November 2023, retroactive amendments to the United States Sentencing Guidelines opened the door to sentencing reductions based on Zero Criminal History Points and Status Points. Also in November 2023, FPD John Gorman retired after 26 years of dedicated, commendable public service and Leilani Lujan was sworn-in as the first FPD of Chamorro ancestry in the nation, the first woman

FPD in our office, and the second openly LGBTQ+ FPD in the nation. In March 2024, our office's first

Assistant FPD of Filipino ancestry, Nicole Cruz Breazeale, joined our team. Biba!

This year marks the 61<sup>st</sup> anniversary of Gideon v. Wainwright. A nation of Public Defenders exists because of Gideon. Our mission to provide zealous advocacy for indigent defendants could not be fulfilled without the CJA Panel attorneys:

Joaquin Arriola, Jr., Cynthia Ecube, William Gavras, Rawlen Mantanona, Heather Quitugua, Joseph Razzano, Curtis Van de Veld, and Louie Yanza. These dedicated attorneys maintain a private practice while also providing a vital public service to our community. We thank them for their tireless efforts, excellence in advocacy and partnership in fulfilling Gideon's promise.

Our office will continue to provide zealous, effective representation for indigent clients charged with federal criminal offenses. We remain committed to the guarantees of the presumption of innocence and every individual's right to equal protection under the law.

## United States Marshals Service

In 2023, the U.S. Marshals Service personnel for the Districts of Guam and CNMI endured an incredibly challenging year.

The operational and administrative staff rallied together after Typhoon Mawar to ensure the courthouse and all USMS office spaces were secured, all court, detention, and enforcement operations were addressed, all district financial obligations were met, and all administrative reports and requests were completed in a timely manner.

The USMS, through the Organized Crime Drug Enforcement Task Force (OCDETF), provided funding to support the multi-agency personnel to work overtime on fugitive cases. This funding was used in executing warrants before and after business hours, resulting in no interruption of court proceedings.

The U.S. Marshals Service and task force members conducted several sex offender compliance checks and fugitive operations

throughout the year.

In summary, the following is list of accomplishments by the U.S. Marshals Service in the District of Guam:

- Executed 22 Justice Prisoner and Alien Transportation System (JPATS) missions, transferring 49 federal prisoners to their designated Bureau of Prisons facilities safely and without incident.
- Executed two multi-agency Sex Offender Compliance operations resulting in the verification of 152 registered sex offenders, 40 for non-compliance investigations or for "failure to register", 15 investigations opened.
- Conducted over 239 domestic fugitive warrant investigations involving federal, state, and local fugitive warrants resulting in 34 federal arrests, 205 state and local arrests.
- Continued international fugitive investigation cooperative efforts with law enforcement counterparts from Micronesia and other Asian

countries.

- Managed approximately \$400,000 in seized asset forfeiture property and monies from federal criminal investigations.

It is indeed a testament to the men and women in the District of Guam that contributed to the successful continuity of operations and execution of the USMS mission during this most challenging time!

## Guam Bar Association

*Buenas yan Håfa Adai Todos Hamyo!*

The past two years have been marked by significant developments, challenges, and exciting new initiatives for the Guam Bar Association. In 2023, we faced three key challenges. Firstly, the Bar struggled with a shortage of criminal defense attorneys, resulting in the appointment of private attorneys to

criminal cases, and a shift of members to inactive status and/or retirement due to the application of the Criminal Indigent Defense Rule. Secondly, membership dropped by 26 attorneys in 2024 due to deaths, retirements, and partly due to the Indigent Defense Rule.

Lastly, in 2023, a Bylaws Election was held. Following the first

election to modify its Bylaws in forty (40) years, 25 members of the Guam Bar sought judicial review of the election results. The Supreme Court upheld the Special Election finding that the Guam Board had complied with its Rules and Bylaws; however, the Supreme Court reserved judgment and opinion on 5 of 31 amendments. To date, the Bar has expended \$12,000 on legal fees after retaining counsel to address this review. Following the Supreme Court's affirmation of the 2023 Bylaws Election on March 21, 2024, the Board announced its appointments to the eight standing committees of the Guam Bar.

Beginning in 2022, the GBA partnered with the New York State Bar Association to develop a Lawyer Assistance Program (LAP) on Guam. This program offers wellness and

mental health services to all our members, including a 24/7 crisis hotline for issues such as depression, anxiety, and substance abuse. This initiative aims to provide critical support and resources to ensure our members can maintain their well-being and effectively serve our community. The Guam Bar can expect upcoming continuing legal education offerings and requirements to ensure that all members are aware of the benefits offered by this invaluable partnership.

Additionally, in the next year, the Guam Bar is exploring an Interest Earned on Lawyer Trust Accounts (IOLTA) program for Guam. IOLTA programs collect interest from lawyers' client trust accounts and direct it to fund legal aid and public interest initiatives, enhancing our financial resources and support for

legal services while improving access to justice.

As we look ahead, we are enthusiastic about the opportunities to fully implement the IOLTA and LAP programs. We remain dedicated to overcoming challenges and fostering growth and resilience within our legal community. The Guam Bar proudly partners with the District Court of Guam to develop programs and opportunities to enhance the lives of every lawyer in Guam. The Guam Bar can anticipate the development of future programs in partnership with the District Court of Guam, Judiciary of Guam, University of Guam, and University of Hawaii, and we hope to see more of our members participate as we look forward to exciting new beginnings for our legal community.

## Ninth Circuit Lawyer Representative

It has been an honor to serve another term as the District of Guam's designated representative for the Lawyers' Representative Coordinating Committee (LRCC). As the LRCC representative, it is my responsibility to work closely with our representatives within the Ninth Circuit to assist in the planning and coordination of presentations for the Chief Judges Conference, the Annual Ninth Circuit Conference, and our Annual District Court of Guam Conference.

The Annual Ninth Circuit Conference took place in July in Sacramento, California this year. The topics selected and presented during this Conference included Generative AI, Climate Conversations, and Native American Tribal Law.

This year, the District Court of Guam and Guam Bar Association worked with the Pacific Judicial Council to co-host the Joint Annual

District of Guam Conference and Pacific Judicial Council Biennial. Topics at this year's Conference will include discussion of Artificial Intelligence, Cyber Hacks, Operations of the U.S. Court of Appeals for the Ninth Circuit, Supreme Court Review, and more. In addition to these topics, an introduction to a pipeline project with the University of Hawai'i at Mānoa William S. Richardson School of Law will be made at this year's conference.

I have been working closely with representatives from the University of Hawai'i at Mānoa William S. Richardson School of Law to find ways make it easier for Guam students to transition from their Undergraduate program to a Juris Doctor program upon graduation from the University of Guam and be successfully admitted to a bar association upon completion of their Juris Doctor program. While we are in the early stages of discussing and bringing this program to life on Guam, our goal is to begin this

pipeline project and reach college students and aspiring attorneys on Guam and across Micronesia within the next 5 years.

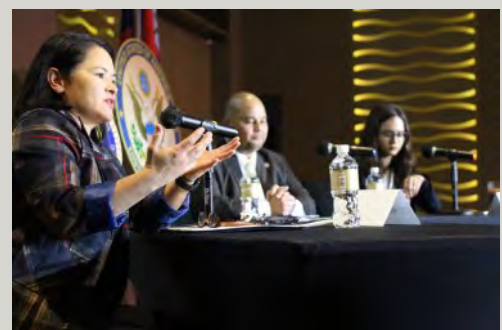

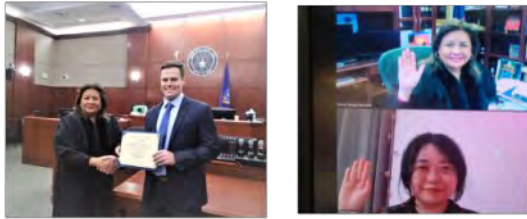

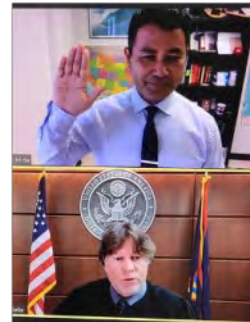
